3. Payment Options

Two payment options are available:

- a) One single payment, due at the time of registration (after invoice has been received), including the entire tuition, the registration/administration fee of \$70.00/student and the class material/book fee of \$60.00/student.
- b) Or two payments: first payment of 50% of the annual tuition plus registration/administration and class material/library fee, due at the time of registration (after invoice has been received); second payment of the remaining 50% tuition due by August 31, 2024.

4. Refunds

Please note: **\$200.00** of the tuition will be **non-refundable** if you **withdraw** your registration **between July 15 and August 31, 2024**. On and after September 1, 2024, no refunds will be given.

5. Registration Procedure

Registration is complete once payment and registration forms have been received. We will contact you only if we have questions pertaining to your registration or if you/your child cannot be placed.

Please note we are <u>not</u> accepting registration forms sent via postal mail as well as check payments. We are accepting email registrations with ACH transfers (via click and pay invoice) <u>only</u>. The Invoice (which also serves as confirmation of registration) will be emailed after we have received your completed registration form via email to info@germanschoolatlanta.com.

<u>Please note</u>: The GSA needs your help. Therefore, during the 2024/25 school year, each family registering with the GSA is required to volunteer a minimum of 5 hours per school year. Volunteer opportunities are plenty, and information will be available throughout the school year. Payment in lieu of time will be accepted.
